Services Provided by the Economic Development Board (EDB)

The EDB's Business Development Department provides free facilitation services for companies planning to establish or expand their business operations in Bahrain. These services include the following:

Administrative Assistance	•Acting as the interface for investor questions relating to establishing a business in Bahrain
Investor Relations Support	•Handholding through the full registration process
Identification of Potential Business Partners	•Establish contacts to high calibre partners (if interested in a joint venture)
Ensuring Access to Resources	•Ensuring access to resources such as access to gas, electricity and water.
Assisting in Property Selection	•Help find the right type of property according to the industry
Access & Training of Local Labor Force	•Introducing investors to entities that provide training (the Polytechnic, Bahrain Training Institute and Tamkeen) and recruitment agencies
Aftercare Services	•Support provided after the company has registered (includes liaising with government entities, assisting with employee related issues and supporting with re-expansion of projects)



No personal income tax


No wealth tax on capital gains

*Although no federal taxation currently exists in the UAE, each of the individual Emirates (Abu Dhabi, Ajman, Dubai, Fujairah, Ras Al Khaimah, Sharjah and Umm Al Quwain) has issued corporate tax decrees that theoretically apply to all businesses established in the UAE.



Businesses Can Be 100% Foreign Owned

- No 'free zone' restrictions
- Companies may purchase land-freehold for commercial usage
- Individuals may purchase land- freehold in prime locations for residential usage & accordingly obtain permanent residency

Developing More Than 120 Trade Agreements

Duty free access of manufactured goods to the Gulf Cooperation Council (GCC)¹ & the Greater Arab Free Trade Area (GAFTA)²

US-Bahrain FTA signed in 2006 (1st treaty signed between the USA and a member of the GCC) offers opportunities, eliminates tariffs & trade barriers with: 96% financial, industrial, services & agricultural duty exempt; tax-free benefits for textiles & garments; 0% export duty on products manufactured in Bahrain; 0% import customs duty on factory raw materials & machinery

4 types of trade agreements including Avoidance of Double Taxation with 37 countries, Investment Protection and Promotion with 29 countries, Economic Trade and Technical Cooperation with 15 countries & the GCC, CAEU & OIC, Reciprocal Exemption from Air Transport Taxes with 41 countries




Total office occupancy costs per workstation - Middle East³





Cost of living index %, Manama=100%







Highly Skilled Workforce

- Bi-lingual highly skilled & educated workforce
- Substantial, ongoing investment in training Bahrainis by Tamkeen
- Tamkeen provides salary subsidies, training & financing grants(BD166M investment in the private sector)
- 2/3 of financial services workforce are Bahrainis, of which 37% are women
- High quality financial focused training institutes and courses

Tamkeen Enterprise Support:



Business Development

Under its Enterprise Development Support Agency, Tamkeen supports the development of enterprises

Through a number of subsidy schemes (Cap of BD15,000 for small companies and BD20,000 for large enterprises):

- •Tasweeg (Marketing): 80% subsidy of the cost of branding, marketing and advertising activities
- •Istishara (Consultancy): 80% subsidy of the cost of consultancy services
- •Tarweej (Exhibition Participation): 80% of the cost of participating in local and international exhibitions
- •Jawda (Quality Management): 80% subsidy of the cost of quality management consultancy services
- •Techania (Technical Assistance): 80% of the cost of purchasing equipment

Access to capital

Through a number of participating banks, Tamkeen can provide enterprises with access to capital up to BD500k, with the support of paying 50% of the interest and guaranteeing 50% of the loan principal (security)

Accounting and Auditing

A largely subsidized two year accounting and auditing service through BDO, E&Y and KPMG

Customized Training Solutions

Tamkeen can support enterprises with customized recruitment and training requirements, with completely subsidized training costs, in addition to wage subsidies up to 18 months.

Career Progression Program

Training subsidy for existing employees and support with wage increment
